

ORDINANCE 1-2021 (Ordinance Setting Tax Rate)

AN ORDINANCE LEVYING TAXES FOR THE MAINTENANCE AND OPERATION OF THE PLEASANTON INDEPENDENT SCHOOL DISTRICT AND PROVIDING FOR THE INTEREST AND SINKING FUND FOR THE YEAR 2021-2022 AND APPORTIONING EACH LEVY FOR THE SPECIFIC PURPOSE.

This year's tax levy to fund maintenance and operations expenditures does not exceed last year's maintenance and operations tax levy. The ordinance, resolution, or order setting this year's tax rate does not require the statements about "tax increase" as specified in §26.05(b) of Property Tax Code.

Be it ORDAINED by the BOARD OF TRUSTEES of the PLEASANTON INDEPENDENT SCHOOL DISTRICT, Pleasanton, Texas;

SECTION 1. That there is hereby levied and there shall be collected for the Maintenance and Operations of the Pleasanton Independent School District and to provide Interest and Sinking Fund for the school year 2021-2022 on all property subject to taxation in the school district a tax of \$1.273418 on each one hundred dollars valuation of property not exempt from such taxation by law or by action or actions taken by the Board of Trustees of the Pleasanton Independent School District, said tax being so levied and apportioned to the specific purpose here set forth:

For the maintenance and operations of the school district, \$1.051700 on each one hundred dollars (\$100) valuation of property, and

For the Interest and Sinking Fund, \$0.221718 on each one hundred dollars (\$100) valuation of property for the payment of principal and interest on debt.

SECTION 2. That this ordinance shall take effect and be in force from and after its passage.
